GenAl use in this course Course coordinators' Guide

Rationale and purpose

The faculty's student guidelines "GenAl use in education @ FSW" and the Brightspace template "GenAl use in this course" with this companion course coordinators' guide was developed by SOLO in response to conversations with instructors and exam boards about the need for clear guidelines and communication towards students about the use of generative Al in teaching.¹

The Brightspace template "GenAI use in this course" has the dual purpose of helping you as a course coordinator to 1) determine if and what use of GenAI is allowed within the context of your course and 2) then communicate this clearly to students via Brightspace. The bilingual Brightspace unit "GenAI use in this course / GenAI gebruik in deze cursus" will be added to all 2425-S1 and 2425-HS Brightspace courses at our faculty. It is up to you as a course coordinator to adjust the information and share it with students.

Please note, because Leiden University does not have an agreement with a GenAl tool such as ChatGPT, Bard, DALL-E, or Bing Chat, it is **not possible to require students** to use them. These services require users to create an account which includes personal data, and the tools are not currently privacy-proof or GDPR-compliant.

- 2. How should I report on my GenAI use for this course?

This course coordinator's guide is intended to assist in the creation of the student manual "GenAl use in this course". You can modify the Brightspace template to fit the learning objectives of your course and your own views on the use of Al within your teaching. The format of the student manual as a Brightspace template allows you to share your expectations of students regarding Generative Al clearly and conveniently within your Brightspace module.

GenAl usage and reporting in your course

When use of GenAI may be allowed and how students should report on this depends on the learning objectives and learning materials for your course. As course coordinator, you determine the details in the course-specific information and provide additional explanation where necessary.

As noted above, it is not possible to require students to use GenAI. This means that these tools are not yet actively supported for use as work forms or practice software. Based on this fact and other ethical considerations, we have specified the following *possible* uses of GenAI based on several sources, see below. Didactical choices are for the course coordinator to make:

Why allow use?

In addition to raising some concerns GenAl also offers opportunities for learning and teaching, such as supporting students in generating ideas, or preparing for debates or exams (see also: 385146eng.pdf (unesco.org). Because no university-wide guidelines or licenses currently exist, the faculty recommends that lecturers use these tools only when it is expected that it supports students in achieving learning objectives.

Our teaching prepares our students for the labour market. In the future, skilful and responsible use of (Gen)Al could become an important part of the professional field. This is an additional reason why it is important to consider whether the use of GenAl can add value to your course.

In allowing usage, it is important to:

- Establish expectations about use (e.g., what is allowed when using GenAl in developing ideas, brainstorming, etc.).
- Consider alternatives [e.g., FeedbackFruits].

In formulating the guidelines for GenAl use in your course and shaping the Brightspace template, go through the following steps:

- 1. Determine if GenAI would be useful in meeting your learning objectives (and if there are alternatives)
- 2. Complete the student template, paying attention to the reporting options
- 3. Make your customized template viewable for your students on Brightspace.

^{*} Feedback should not replace (part of) your actual writing.

Considerations for step 1

It is important to consider for yourself whether and how GenAI can help your students and to what extent that help may go:

• Didactical considerations

For example, if it is important in your course that students learn to think critically and you want to allow the use of GenAl for "Idea development/brainstorming", then it is important that you properly define this use. Are they allowed to submit the idea to a chatbot like ChatGPT for additional input? Can they use the chatbot to refine their research question? To counter their own assumptions? To check their line of argument? When does its use prevent proper assessment of the student's product? In all cases, use must be in line with your learning objectives and use of GenAl should not be mandatory.

Technical alternatives

For example, if you want to allow GenAI for getting feedback on writing style, citation style and/or structure, we recommend considering the use of Automated Feedback from FeedbackFruits. This is a university-supported tool available within Brightspace. Please note, (for now) feedback on writing style is only available in English. SOLO is happy to help you with this: solo@fsw.leidenuniv.nl.

• Clear communication to students

For example, any permitted use of GenAI "Idea development/brainstorming" may require further explanation from you as an instructor. Indicate clearly within the template what you think is permitted.

Reporting options

For transparency about GenAI use, in addition to proper citation, ask students to attach the prompts or the full chat history and/or reflect in the text on what the use of GenAI has provided them. Include the required reporting options in the template and clearly explain to students what you expect of them.


Advice

Practical Instruction

You can remove the underlying items that do not match the language of your course (or keep them Hidden for students).




The underlying item "GenAI use in this course" is the template with the course-specific information.

Edit the information in the "GenAl use in this course" template via the **Edit** option.

After your adjustments, make sure you switch the unit and underlying items (that match the language of your course) from Hidden to **Visible**, so that the information is visible to students.
